- Boost skills and employability
- Modernise education, training and youth work
- Focus on young people







#### Key facts about Erasmus+

- Cross-sectoral structure based on 'Key Actions'
- Worth €940m to UK over seven years
- Replaces Lifelong Learning Programme,
  Youth in Action and other EU programmes



#### Lifelong Learning Programme



The new programme is for organisations across all sectors actively involved in delivering formal and non-formal education and training, youth and sport activities.

#### Schools Priorities

- Improving the attainment of young people, particularly those at risk of early school leaving (ESL)
- Improving the attainment of young people with low basic skills in Maths, Science and Literacy
- Developing high quality and accessible Early Childhood Education and Care services
- Revising and strengthening the professional profile of the teaching professions







#### **Key Actions**

- Key Action 1: Learning Mobility of Individuals
- Key Action 2: Co-operation for Innovation and Exchange of Good Practices
- Key Action 3: Support for Policy Reform







#### Key Action 3

- Meetings between decision-makers and young people in the field of youth
- Funding for structured dialogue to support policy making







#### Key Action 2 Strategic Partnerships

- Open to Higher Education, Vocational Education and Training, schools, adult education and youth
- Funding for development, transfer and/or implementation of innovative practices (including mobility for staff and pupils in schools)
- Partnership size and type flexible
- Minimum of two partners from two countries (for schools only or LA only partnerships) otherwise minimum of three
- Partnerships will last 2 or 3 years
- First application deadline 30 April 2014







#### **Key Action 1**

- Open to Higher Education, Vocational Education and Training, schools, adult education and youth
- Funding for study, work experience, job shadowing, training and teaching

- No individual applications, organisations only
- First application deadline 17 March 2014







#### Key Action 1 for schools

- Applications are project-based
- Will involve staff mobility as many as you like
- LAs will not be able to apply
- Projects can last 1 or 2 years







# Key Action 1 for schools supports learning mobility of staff that:

- Is framed within a European Development Plan aimed at modernising and internationalising
- Is well prepared
- Has recognised outcomes
- Disseminates results







#### European Development Plan (E.D.P.)

- The needs of the school in terms of quality development and internationalisation
- How the planned activities will contribute to meeting these needs
- The impact expected on pupils, teachers and other staff, and on the school overall
- How schools will integrate the competences and experiences acquired by their staff into their curriculum and/or the school development plan
- How eTwinning is going to be used in connection with the planned mobility activities, if relevant







#### eTwinning- what is it?

- School collaboration and school networking in Europe through the use of Information and Communication Technologies (ICT)

# eTwinning allows you to:

- Find potential partners/receiving organisations abroad
- Use project tools
- Participate in online learning events
- Cooperate intensively among all schools during and after the staff mobility project









# Key Action 1 for schools: Types of mobility activity









#### Structured courses

- Can be in any field, but should be justified by E.D.P.
- Must take place in one of the programme countries
- Should last between 2 days and 2 months
- Do not need to be identified at application stage







#### Job shadowing

- Opportunity to shadow a colleague in a partner school
- Partner(s) should be identified at application stage
- Can be between 2 days and 2 months







#### Teaching in a partner school

- Teachers or other school education staff can be funded to teach at a partner school abroad
- Up to two months placements possible
- Differs from job-shadowing in that partners will not be observed







#### Activity plans

- The expectation is that a school will have a suite of mobility activities over the lifecycle of the project
- Can involve any school staff, in any numbers, any combination of mobility activity type, to any programme country ...







#### **Funding**

- Unit costs so set rates per day per participant
- Funding for:
  - Travel
  - Individual support (subsistence)
  - Organisational support
  - Course fees
  - Special needs

#### ECAS and PICs

- Before being able to apply for Erasmus+ funding:
- Register your organisation on the <u>European Commission Authentication</u>
   <u>Service (ECAS)</u>, if not already registered. For guidance on registration, see
   our <u>How to Register on ECAS</u> video and guide
- Log in to the <u>Participant Portal</u> with your ECAS account details and register your organisation on the <u>Unique Registration Facility (URF)</u> to obtain your unique Participant Identification Code (PIC), if not already registered. The European Commission has produced a <u>Participant Portal User Manual</u> to help guide you through the process of registering on the portal.
